LOCAL RISK FACTOR: High.

CITY OF UNALASKA COVID-19 CASE COUNT: There are 0 confirmed cases in Unalaska and there is no change in number of tests from Friday.

Patients tested in Unalaska	50
Confirmed Negative Tests	50
Confirmed Positive Tests	0

STATE OF ALASKA COVID-19 CASE COUNT: There are 370 confirmed cases in the state, with 263 people recovered.

FAMILIES ENCOURAGED TO CREATE CIRCLE OF SUPPORT: The State of Alaska has developed resources to help families with small children create a "Circle of Support" – a plan for what to do if caregivers become ill with COVID-19. A Circle of Support consists of people that parents can call upon to provide short or long-term child care. People who are at high risk for suffering severe complications with COVID-19 should be excluded from the Circle of Support, but it is important to identify people who can possibly care for children in an emergency or if the parents become ill. "Go-Bags" for children are also encouraged, containing contact information for each member of the Circle of Support; extra clothing; lists of known allergies and medications; and comfort items like blankets or stuffed animals.
