Yes, the Senior Fire Captain occasionally works in extremely hazardous conditions. Extreme effort is often required in dealing with fire or other dangerous elements. The work environment is often extreme with long hours, working in inclement weather to include cold, heat, wind, rain, snow. In addition to night work, working in high noise areas, around moving parts and machinery, in elevated places. Occasionally exposed to noxious fumes, airborne particles, blood and airborne pathogens, toxic or caustic materials, risk of electric shock, vibration and working in confined spaces. Emergency or non-traditional work hours are often necessary.
