Re: Ordinance 2026-02: Creating Budget Amendment #4 to the FY26 budget to appropriate \$184,000 from the General Fund and Increase the Police Budget by the same amount

Purpose: to fund a contract with Turbo Tags & Titles to provide DMV services in Unalaska

**SUMMARY:** Ordinance 2026-02 will provide funding to contract with Turbo Tags & Titles to provide DMV services in Unalaska for up to two months.

**PREVIOUS COUNCIL ACTION:** There has been no prior council action regarding this ordinance. Earlier this evening, Council considered Resolution 2026-04 authorizing an agreement with Turbo Tags.

**BACKGROUND & DISCUSSION:** Please see the [Memorandum to Council related to Resolution 2026-04](#).

**ALTERNATIVES:** Alternatives include: (1) take no action; (2) introduce the ordinance and amend the amount; or (3) introduce the ordinance as presented.

**FINANCIAL IMPLICATIONS:** \$172,000 will be transferred from the General Fund to the Police Department administration budget.

**LEGAL:** None.

**STAFF RECOMMENDATION:** None. While local access to DMV services is important to residents and to the business community, the cost of deploying a private contractor to provide mobile DMV services is significant and must be weighed against the benefits to individuals, employers, and the local economy. Council must determine whether the expenditure of public funds for this temporary service is warranted.

**PROPOSED MOTION:** If Resolution 2026-04 is not adopted authorizing the agreement with Turbo Tags, it makes no sense for this ordinance to proceed. If council decides to proceed, on first reading the proposed motion is: I move to introduce Ordinance 2026-02 and schedule it for public hearing and second reading on January 27, 2026.

*Second Reading:* I move to adopt Ordinance 2026-02.

**CITY MANAGER COMMENTS:** Local access to DMV services is important to residents and to the business community. The cost of deploying a mobile DMV office is significant and must be weighed against the benefits to individuals, employers, and the local economy. Council is asked to determine whether the expenditure of public funds for this temporary service is warranted.
